- Chair covered aims of AGM
- Apologies were given, please see above.
- It was raised by Mark that we no longer need to file the AGM minutes with the Charity committee.
- Chairs report
  - Highlighted current PTA committee had to pencil in a few events, such as Discos and Christmas cards so dates were booked in.
- Treasurers Report
  - Covered where money was spent on the school
  - o Detailed the activities that FoRE supported
  - Noted Employee donations brought in £800 If we could encourage more parents and guardians to look into match funding this could really help raise money for the school.
  - Highlighted that Discos and the fun run are very good and raising funds for FoRE.
  - Circus will be included in next year's accounts, however noted it raised circa £3000 in ticket sales alone.
- Independent examiner of accounts for the year:
  - Mark Solocombe is our independent examiner.
  - $\circ$   $\;$  Aimis to provide an independent review of trustees managing their funds.
  - It is a requirement of the charities committee.
  - No issues were found.
  - Mark confirmed he is happy to carry on in this role and be the independent examiner for the new year 2023/2024
  - Also mentioned that login to charities committee was once a shared login. This has to change and an executive committee member must have the login, so needs to be transferred by Mark.
- Last year's AGM minutes were reviewed. No matters arisen.
- Headteachers update
  - Really interesting to here last AGMs minutes, and great to see we achieved what we set out to in the PTA
  - Appreciates all the hardwork and effort Pippa and the team have put into create events for the children and raising money for the school.
  - Proud of the community we have, and how it helps the school. Budgeting for everything is very hard, so support with that is so valuable.
